- (i) Who launched the Khilafat Movement in India? Mention *two* other causes of the Non-Cooperation Movement. [3]
- (ii) Mention *any three* points to analyse the impact of the Non-Cooperation Movement. [3]
- (iii) Mention *any four* clauses of the Gandhi-Irwin Pact. [4]

Question 8

India's last Viceroy released a plan on the country's independence from the British on June 3, 1947. The plan came to be celebrated as the 'last plan for independence'. He was appointed Viceroy to India to speed up the process of transfer of power by the then British Prime Minister Clement Atlee.

- (ii) Mention *any three* reasons given by the Congress to justify the acceptance of the plan. [3]
